Dear National Veterans Small Business Coalition (NVSBC) Members:

I am writing you at a critical moment for NVSBC members to request your help with a very important new campaign. We have engaged a DC-based public relations firm to help us shame the U.S. Department of Veterans Affairs (VA) into obeying the U.S. Supreme Court's unanimous decision on the Kingdomware Technologies case. To help finance this effort, the NVSBC Board of Directors has authorized me to seek financial contributions from our members.

A decade ago, the GAO informed the VA that it was wrong on VETS First. Last year, we were thrilled that the Supreme Court agreed and unanimously ruled against the VA in the Kingdomware Technologies case. While this should have put an end to the issue on VA procurement policies for Veteran-owned businesses, it did not.

In June 2016, the VA issued a staff guidance procurement memo on the VETS First Supreme Court decision that **misinterprets the Supreme Court decision**.

Over the past eight months the NVSBC has met with senior VA leadership about the problems with the procurement memo and the fact that the agency is ignoring its own acquisition policies. Nevertheless, the VA continues to:

- Procure open market medical surgical items and industrial supplies from large business prime contractors without regard to VETS First.
- Contract using "Strategic Sourcing" to the detriment of veterans in the office products industry.
- Place "Ability One" vendors ahead of Veteran owned small businesses.
- Send requirements to other agencies to contract for VA.

The agency is now attempting to contract with commercial firms to avoid VETS First all together by contracting the VA contracting functions. This is **a slap in the face of the Veteran community**.

Enough is Enough

The VA and large corporate interests are marshalling forces against VETS First to ensure our Veteran small businesses are NOT given first consideration for federal prime and subcontract procurement opportunities.
